**CONSTITUTION AND FUNCTIONING OF THE INTER-INSTITUTIONAL WORKING  
GROUP FOR UNDERTAKING OF THE PROCEDURES OF THE ALBANIA  
CANDIDACY AT THE EXTRACTIVE INDUSTRIES TRANSPARENCY  
INITIATIVE (EITI)**

In accordance with point 3 of the article 102 of the Constitution of the Republic of Albania, and point 1, of the article 12 of the law Nr. 9000, date 30.01.2003, “ For the organization and functioning of the Council of Ministers”,

**ORDER:**

6. Constitution of the inter-institutional working group to carry out all the procedures for the candidacy of Albania with full of rights as candidate implemented country of the Extractive Industries Transparency Initiative (EITI).
7. Head of the Working group is the Deputy Minister of the Economy, Trade and Energy and the working group is composed from the following members:
  - l) Two representatives from Ministry of Economy, Trade and Energy
  - m) One representative from Ministry of Finance
  - n) One representative from Ministry of Foreign Affairs
  - o) One representative from Ministry of Justice
  - p) One representative from Ministry of Labor, Social Issues and Equal Chances
  - q) One representative from General Directorate of Taxes
  - r) One representative from General Custom Directorate
  - s) One representative from Institute of Statistics
  - t) One representative from National Agency of Natural Resources
  - u) One representative from National Geological Service

- v) One representative from Agency of Concessions
- 8. Invited from the head of the working group, in the meeting of working group shall participate representatives from nonprofit organizations, Albanian Bank, Energy Regulatory Agency, groups of interest, Union of the Trade and Industry.
- 9. Inter- institutional working group has to undertakes all the necessary measures to ensure the realization of the action plan, to prepare all the needed documentation in order to realize the beginning of the validity process towards candidacy of the Albania as candidate implemented country of this Initiative in the Global Conference of the Extractive Industries Transparency Initiative (EITI), which will take place in DOHA on 16-17 February 2009.
- 10. Inter- institutional working group has to undertakes all the necessary measures to ensure the realization of the action plan, prepare all the needed documentation in order to realize the candidacy of Albania with full of rights as an implemented country of this Initiative.

This order became in power immediately.
